Kinship Care

Kentucky has different types of kinship care — both formal and informal



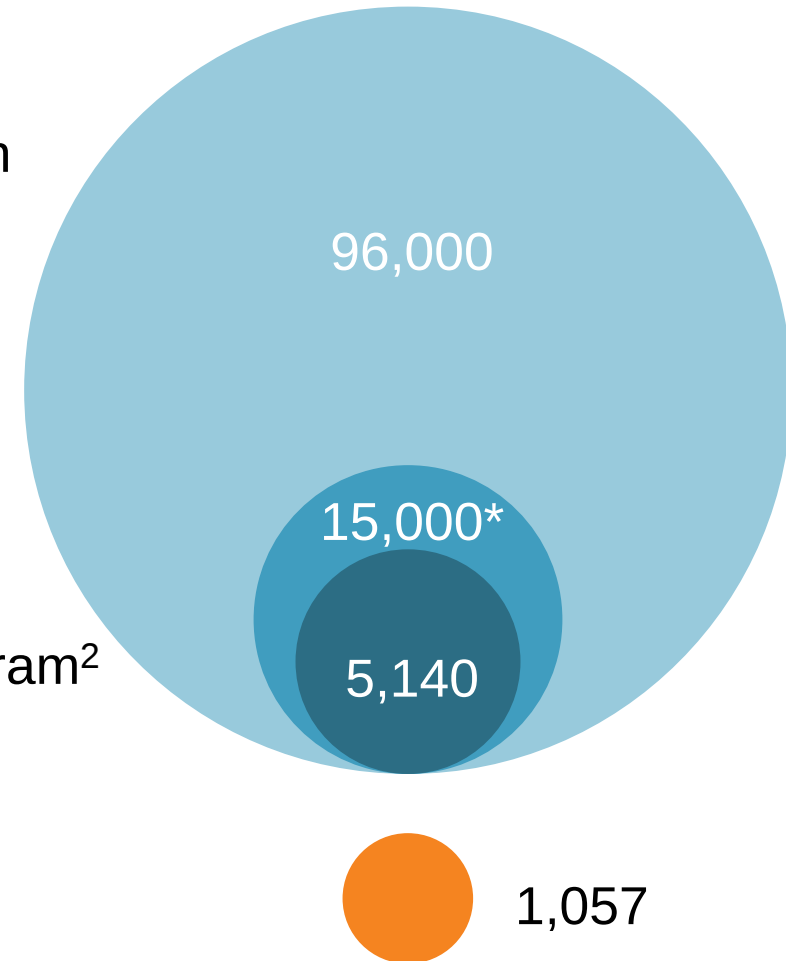
- **Informal kinship care.** Children who live with relatives or close family friends who have varying types of custody depending on arrangements made within those families
- **Kinship care/Fictive Kin.** Children who are placed with **relatives** or **close family friends (fictive kin)** as a result of an investigation and removal by the Department or Community Based Services (DCBS)—custody of the child is maintained by the relative or DCBS
- **Relative foster care.** Children placed with relatives or close family friends who have become certified as foster parents—custody of the child is maintained by DCBS

The Previous Kentucky Kinship Care Program

- The Kentucky Kinship Care Program provides \$300 a month per child for kinship caregivers who take in children who have experienced abuse and neglect and placed by the Department for Community Based Services (DCBS).
- **No new kinship families have been able to enroll in this program** since April 2013.

- **Reduced requirements for relative and fictive kin caregivers**
- **\$6.00 per diem until foster home approved**
- **Training requirements met**
- **Other foster care requirements met**

Relative Caregiver Program

Potential Financial Resources—Relative Caregiver Program

Relative Placement Support Benefit – Relatives may be eligible to receive a monetary benefit based on each child's immediate needs. The social worker who placed the child(ren) in the home should discuss this benefit with you. (\$350—1 time)

Child Care Assistance (CCAP) – Please contact your social worker to learn more about qualifying for the Child Care Assistance Program.

Kinship Care

Legal supports

Legal Supports: House Bill 1 established the possibility of de facto custodians (kinship caregivers) to get legal representation.

A person who has been shown to have been the primary caregiver for, and financial supporter of, a child who has resided with the person for a period of six (6) months or more if the child is under three (3) years of age and for a period of one (1) year or more if the child is three (3) years of age or older or has been placed by the Department for Community Based Services.

6th Circuit Court Ruling—D.O v Glisson.

- An October 2017 federal court ruling by the U.S. 6th Circuit Court of Appeals required that KY must pay relatives who serve as foster parents in the same manner it pays adults who are licensed as foster parents if the Department for Community Based Services (DCBS):
 - Places the child with the relative
 - Conducted a home study and background checks,
 - AND if CHFS either retains custody of the child or has transferred the child from CHFS' custody to the temporary custody of the relative or fictive kin.

Payment amounts vary depending on a child's needs but average about \$750 a month per child.

6th Circuit Court Ruling (continued)

- Individuals are encouraged to email CHFS at: **DCBSCChildProtection@ky.gov** if they think they might qualify. Please include your name, phone number, child(ren) name(s) and date of birth for each child. Email correspondence is the most efficient way to start the process of determining eligibility.
- If email is not an option, families and caregivers who think they may be eligible for the relative or fictive kin payment can contact the CHFS Kinship Support Hotline at **877-565-5608**.

'Grandma Underground' still fighting for Kentucky kinship care payments

ELIZABETHTOWN, Ky. — Sent from the "Grandma Underground," the personal stories included pleas for help from grandparents and other relatives struggling to raise children removed from homes because of abuse and neglect, often from parents caught up in the state's drug epidemic.

"She was born a drug baby and has a lot of medical problems and suffers many withdrawal attacks," wrote Teresa Grider, a grandmother from Elizabethtown, describing the youngest of five grandchildren she's raising. "If you was ever to see one, it would make tears come to your eyes as it does me."

A grandmother from Murray wrote: "We are at the point of losing our home now and struggle from week to week. I still don't understand why relatives, whether they have temporary or permanent custody, don't get the same benefits as foster parents."
